



BEVERLEY BARRACUDAS SWIMMING CLUB PRIVACY NOTICE FOR USERS OF OUR WEBSITE

Beverley Barracudas Swimming Club respects the privacy of our website users. The purpose of this privacy statement is to ensure we interact with all of our users in line with current legislation such as the General Data Protection Regulation 2018 (the GDPR) and in accordance with their wishes.

References to **we**, **our** or **us** in this privacy notice are to the **Beverley Barracudas Swimming Club**

1) We will use any personal information collected from the website in accordance with all laws and regulations relating to the protection of personal data including the GDPR. Further details on the GDPR can be found on the Information Commissioner's website at www.ico.gov.uk

2) The information collected on the website includes:

2.1. the users' **Internet Protocol (IP) addresses**, which is automatically logged by our web server. IP addresses are used to observe users' interest in this website (number of visits, etc);

2.2 **cookies** which are very small text files saved to your computer and used to track the user navigation around a website. Session cookies are also used to store information on which content, including advertisements, have been seen by a user. Some areas of the site will use persistent cookies which are permanently stored on the users' computer. We will use such cookies to identify unique users to our website.

We use web beacons and cookies to measure the effectiveness of our advertising and how visitors use our site. This information helps us learn things like what pages are most attractive to our users and which of our products are most interesting to our users.

Beverley Barracudas Swimming Club also uses a third party (WIX.com) to deal with advertisements on this site. The advertisers may use cookies to track the number of users responding to the campaign. The Club does not have access to or control cookies placed by third parties.
